## Course Outline

### Module 1: Overview of Federal Grant Law and Policy

- Identify core sources of federal grant authority.
- Understand the hierarchy of legal and policy requirements.
- Recognize how grant law differs from procurement law.

### Module 2: Authorizing Statutes and Appropriations

- Interpret statutory authority for grant programs.
- Understand appropriations constraints.
- Identify implications for allowable activities and funding use.

### Module 3: Federal Grant and Cooperative Agreement Act

- Explain the purpose and scope of the Act.
- Distinguish grants, cooperative agreements, and contracts.
- Apply the Act to award selection decisions.

### Module 4: The Uniform Guidance (2 CFR Part 200)

- Understand the structure and purpose of the Uniform Guidance.
- Identify key requirements affecting grant management.
- Apply regulatory provisions to operational decisions.

### Module 5: Agency-Specific Policies and Terms

- Identify agency supplements and policies.
- Understand the role of award terms and conditions.
- Recognize conflicts between policy and regulation.

### **Module 6: Administrative Discretion and Limits**

- Identify areas where agencies and recipients have discretion.
- Recognize limits imposed by law and regulation.
- Avoid informal practices that exceed authority.

### **Module 7: Legal Risk and Oversight**

- Identify legal risks in grant management.
- Understand oversight roles of OMB, GAO, and Inspectors General.
- Recognize how legal issues become audit findings.

### **Module 8: Enforcement, Remedies, and Corrective Actions**

- Understand enforcement authorities under federal grants.
- Identify available remedies and sanctions.
- Apply proportional responses to noncompliance.

### **Module 9: Documentation and Defensibility**

- Document decisions grounded in legal authority.
- Prepare grant files for legal and audit review.
- Avoid documentation gaps that increase risk.

### **Module 10: Capstone Simulation – Applying Grant Law and Policy**

- Apply legal and policy concepts to a realistic scenario.
- Identify appropriate authorities for decisions.
- Support defensible grant management actions.
