Course Outline

Module 1: Purpose and Role of Cooperative Agreements

- Explain when and why cooperative agreements are used instead of grants.
- Identify statutory and regulatory authority governing cooperative agreements.
- Describe substantial federal involvement in practical terms.

Module 2: Regulatory Framework and Oversight Expectations

- Identify 2 CFR 200 provisions applicable to cooperative agreements.
- Understand agency-specific policies governing federal involvement.
- Recognize oversight expectations from OMB, IGs, and Congress.

Module 3: Roles, Responsibilities, and Boundaries

- Distinguish federal versus recipient responsibilities.
- Identify risks associated with role confusion and informal direction.
- Establish clear boundaries to preserve accountability.

Module 4: Monitoring Cooperative Agreements

- Design monitoring approaches that reflect substantial federal involvement.
- Integrate technical engagement with compliance monitoring.
- Avoid over-monitoring and inappropriate direction.

Module 5: Performance Management in Cooperative Agreements

- Assess performance within collaborative program structures.
- Interpret milestones, deliverables, and shared outcomes.
- Identify early warning signs of performance failure.

Module 6: Financial Oversight and Cost Management

- Monitor costs and drawdowns in cooperative agreements.
- Identify financial risks unique to shared federal involvement.
- Distinguish technical guidance from financial control.

Module 7: Managing Change and Federal Direction

- Navigate scope changes, approvals, and amendments.
- Document federal input without directing recipient operations.
- Manage evolving program needs defensibly.

Module 8: Addressing Noncompliance and Performance Issues

- Identify compliance and performance issues through monitoring.
- Determine appropriate responses consistent with cooperative agreement authority.
- Coordinate corrective actions and technical assistance.

Module 9: Documentation and Defensibility

- Document federal involvement clearly and consistently.
- Avoid documentation gaps that increase audit risk.
- Prepare cooperative agreement files for audit and IG review.

Module 10: Capstone Simulation — Managing a Cooperative Agreement

- Apply cooperative agreement management concepts to a realistic scenario.
- Identify appropriate federal involvement actions.
- Document decisions suitable for audit and oversight review.
