## Course Outline

### Module 1: Why the FAR Was Overhauled: Strategic Context & Intent

- Apply practical navigation strategies for working effectively in the streamlined regulatory framework.

### Module 4: Strategic Acquisition Guidance (SAG): Applying Judgment Beyond the FAR

- Explain the purpose and role of Strategic Acquisition Guidance (SAG) in the modernized framework.
- Differentiate between regulatory requirements and non-regulatory SAG tools.
- Identify key SAG components — including the FAR Companion Guide, Practitioner's Albums, and Category Guide — and how to apply them.

### Module 5: Category Management & Government-Wide Contracting

- Describe OFPP direction on category management and enterprise buying strategies.

- Differentiate between best-in-class and preferred government-wide contract vehicles.
- Understand mandatory-use expectations and the conditions under which exceptions apply.
