Master Certificate in Federal Financial Management Level I Certificate Program

Designed for early-career federal financial professionals, this Level I certificate establishes foundational expertise in key areas of financial management. Participants will build skills in accounting, budgeting, appropriations law, and analysis through required courses and targeted electives.

- Understand basic budget formulation and execution.
- Learn key components of appropriations law and compliance.
- Apply introductory tools for data interpretation and decision support.

Master Certificate in Federal Financial Management Level II Certificate Program

This Level II certificate program helps federal financial professionals expand their knowledge of budget formulation, execution, and decision support. Through focused coursework, participants gain the tools to interpret financial data, navigate congressional budget processes, and contribute to resource planning and performance evaluation.
