Monitoring Grants Course

Participants learn the language of monitoring, the linkage between risk and internal control, and how to select and execute the right mix of oversight techniques.

- · Communicate results and required follow-up.

Compile final technical and financial reports and property records.

- Resolve open items and confirm audit/reporting completion.
- Establish retention timelines and transition obligations.
